A Message from the President

Publication of the Fourth Annual Review

I am pleased to present the 2011 Annual Review. This is first such review since I became president of The Open University of Japan (OUJ) in May 2011.

The Annual Review was first published during the 2008 academic year and this year marks its fourth edition. The Annual Review summarizes the achievements of OUJ over the past year, looks back on educational, research and overseasoriented activities and also serves to record milestones that occurred during the year. In addition, it introduces multimedia lectures, face-to-face lectures, study centers, libraries, ICT and Distance Education Center activities and major OUJ events such as the graduation and degree conferment ceremony.

The 2011 academic year was also a milestone year for OUJ Foundation, which celebrated the 30th anniversary of its founding, and also coincided with other achievements. In July, we completed the transition to digital terrestrial broadcasting, with the exception of areas affected by the Great East Japan Earthquake, and our channel-12 terrestrial digital broadcast begun in the Kanto region in 2006 has now been permanently established. Further, OUJ also managed to acquire a channel when the expansion of BS broadcast channels was started in October.

As a result, OUJ has become widely known not only in the Kanto region but through Japan.

In addition to broadcasts, utilization of the Internet has also taken off. For a number of years, Chairperson SHIRAI, who assumed his new post a month before me in April 2011, led efforts in support of ICT utilization at his previous school. I have also brought experiences from my previous posting and conducted similar activities at OUJ. In that sense, OUJ Foundation's 30th anniversary was also a milestone year for Internet utilization, despite its position as a means to supplement

our traditional broadcasting.

In fact, we have made significant progress in the distribution of broadcast materials over the Internet and the webbased submission of questions used in tutorials through correspondence. Moreover, in light of the characteristics of OUJ, whose students are comparatively older than those at regular universities, we have also made headway in terms of student-side IT adoption, through IT literacy education at nationwide study centers, and other means.

On the topic of our nationwide network of study centers, in April the Yamaguchi Study Center relocated to within the Yamaguchi University Campus, while in September, the Tokyo Bunkyo Study Center moved to a new building at its old location in Myogadani. Also, in April 2012 the Tokyo Shibuya Study Center opened as our first "Urban Campus."

Through this Annual Review, I hope you will gain an appreciation for the many changes which have taken place.

2011 Graduation and Degree Conferment Ceremony

The graduation and degree conferment ceremony for the 2011 academic year was held on Saturday, March 24, 2012 at NHK Hall in Shibuya, Tokyo. As the ceremony for the 2010 academic year was cancelled due to the Great East Japan Earthquake, graduates and those who completed graduate programs from the 2010 fiscal year also attended this year's ceremony, which brought together more than 2,000 people in total.

The ceremony begun with the university song, which was followed by addresses by President Yoichi OKABE, Education, Culture, Sports, Science and Technology Minister Hirofumi HIRANO, Internal Affairs and Communications Ministry Deputy Director-General Shuichi INADA and OUJ Alumni Association

Federation Director Tetsuo ONO. Reply addresses were then delivered by valedictorians Akiyoshi TAKAHASHI (Natural Sciences Program) and Mihoko ADACHI (Sciences of Human Development and Education Program, School of Graduate Studies of Arts and Sciences). Subsequently, a total of 34 graduates, comprising 15 from the 2010 academic year and 19 from the 2011 academic year, were honored by the President as "Prestigious Open University of Japan Graduates."

For the 2011 academic year, 4,544 Faculty of Liberal Arts students graduated and 380 graduate students completed their School of Graduate Studies programs.

Response to the Great East Japan Earthquake

At 2:46 p.m. on March 11, 2011, a magnitude 9.0 earthquake, the largest to hit Japan in recorded history and measuring the maximum 7 on the Japanese seismic intensity scale, struck the Tohoku region, wreaking catastrophic damage to the Pacific coastal areas of the Kanto and Tohoku regions. OUJ study centers and satellite spaces also suffered enormous damage, primarily in the Tohoku and Kanto areas.

Damage Situation at The Open University of Japan

Study centers and satellite spaces in the Tohoku District (Hachinohe, Iwate, Miyagi, Akita, Yamagata, Fukushima, Iwaki) and Kanto District (Ibaraki, Tochigi, Chiba, Tokyo Bunkyo, Tokyo Adachi, Tokyo Tama) suffered damage

such as collapsed bookshelves, scattered books, partial wall peeling and power outages, but buildings remaind intact buildings.

The Bonds of 80,000 OUJ Students Nationwide

Immediately after the earthquake, OUJ decided to collect donations for the disaster affected areas. Later, OUJ started collecting donations aimed at those connected with the university in the form of a "Great East Japan Earthquake Manapi Fund" and provided support through scholarship funds and consolatory payments to fellow students exhibiting the strong will to continue studying despite being affected by the disaster.

Study centers around Japan also delivered streams of relief supplies and messages of encouragement to the centers affected by the disaster.

Learning Support for Students Affected by the Disaster

The Open University of Japan instituted a number of support measures to help students affected by the Great East Japan Earthquake or related nuclear power plant incident, including current students who experienced significant difficulties completing their courses for economic reasons, and enrolling students. The measures included the waiving of enrollment fees, tuition fees and other costs, and the pro-

vision of free printed course materials for students who lost them in the disaster.

In addition, immediately following the earthquake the Student Support Center established a dedicated toll-free number for the disaster-affected region. The center handled between 10 and 50 consultations per day from students with problems or worries about continuing their studies.

University Research and Activities Aimed at Future Disaster Prevention

Since before the Great East Japan Earthquake, The Open University of Japan has provided regional disaster prevention support through class-based courses, public lectures and other efforts aimed at preventing or reducing the damage caused by major earthquakes and tsunami. Following the Great East Japan Earthquake, OUJ has utilized the lessons learned from the earthquake in its research and educational activities, contributed members to disaster task forces at the local and national government levels, and placed an energetic focus on activities to support regional disaster prevention, such as holding public lectures.

Broadcast Lectures

Broadcast lectures and classroom sessions are pivotal to academics at the Open University of Japan (OUJ). As of the 2nd Semester of 2011 academic year (October 2011 to March 2012), the number of subjects available stood at 257 Faculty of Liberal Arts subjects and 68 School of Graduate Studies subjects, for a total of 325 subjects. As the broadcast lectures are in principle offered for four years (two semesters a year, totaling eight semesters), approximately one quarter of the total number of subjects offered is subject to replacement each year.

New subjects offered in 2011 academic year included 54

Faculty of Liberal Arts subjects (32 TV, 22 Radio) and 16 School of Graduate Studies subjects (4 TV, 12 Radio) totaling 70 subjects.

Internet Distribution

In 2007, the Open University of Japan began offering broadcast lectures over the Internet (streaming) through its dedicated student website (Campus Network Website). The number of courses offered in this way is increasing each year, and now almost all radio courses are distributed via the Internet. In the 2011 academic year, 72 TV subjects, 156 radio subjects and 42 special lectures were covered by Internet distribution.

Along with broadcast lessons, classroom sessions are pivotal to academics at the Open University of Japan, and are conducted at 50 Study Centers and seven Satellite Spaces nationwide. In 2011 academic year, 2,884 subjects (1,386 in the 1st Semester and 1,498 in the 2nd Semester)

Classroom session subjects are face-to-face classes taught by full-time OUJ teaching staff and visiting local lecturers. Students meet lecturers, and encounter other students as well, through classroom sessions.

What's more, in keeping with the characteristics of the Faculty of Liberal Arts, subjects cover a diverse range of content, and the same goes for class formats, which may include activities such as field work or tours of facilities in addition to regular lectures and experiments. Different locations provide lectures under a uniform theme, such as the "Culture and Climate" series of collaborative classroom sessions organized by the Hokkaido and Tohoku blocks.

To inform students of their grades as guickly as possible to help them plan which courses to take, students who take classroom sessions from the 2nd Semester of 2011 academic year will have their grades from classroom sessions taken in the first half of the semester listed on System WAKABA as tentative grades. We continuously review our systems to ensure that we provide motivated students with as many opportunities to learn as possible.

Under the Faculty of Liberal Arts, The Open University of Japan offers some 300 subjects through television and radio covering a broad range of academic fields. For instance, among psychology-related subjects alone more than 20 subjects are offered, from basic to specialized topics. For this reason, selecting the subjects they want to study can quite a difficult task for students.

To address this, a "Course Information" program (15-minute television program) where senior instructors explain the content and key points of subjects as well as provide learning advice was started in 2010 academic year. To date, more than 50 subjects have been introduced through the program. As well as introducing a wide range of subjects through nationwide television broadcasts every other day, course information can also be accessed through the website. We continue to our course selection services, which make use of Internet-based search tools.

With "Find it! Course Navi," we help students find the motivation to learn based on various conditions such as study theme, broadcast times and searches for subjects in specialized fields in conjunction with OUJ experts. Students can also search for the some 3,000 classroom sessions (schooling) offered all over Japan to find the classes that interest them based on class times, study center or keywords. Looking ahead, OUJ plans to upgrade its Internet services to better

accommodate thelearning approaches of individual students.





Providing Learning Support to Students in Need of Special Assistance to Ensure a Pleasant Learning Experience for Everyone

The Open University of Japan has established a range of study support systems to ensure that every student is free from impediments to learning opportunities and is not put at a disadvantage. For example, as a support measure for hearing-impaired students, we provide subtitled programs for our television broadcast lecture subjects. In the 2nd Semester of 2011 academic year, 55 subjects were broadcast on television along with subtitles, representing roughly 32% of all television broadcast subjects. Of the 52 special lectures broadcast, 31 (roughly 60%) were shown with subtitles.

In addition, during credit certification examinations OUJ

has developed special measures under its handicap system, such as separate exam-taking rooms and extended examination times. For instance, during credit certification examinations for the 1st Semester of 2011 academic year, audio questions were offered for 84 subjects, with a total of 103 eligible students taking advantage of the service. Similarly, questions were offered in Braille for 83 subjects, and a total of 116 eligible students took the examinations in this way. On an as-needed basis, OUJ also conducts credit certification exams at special-needs schools or in hospitals, with eight students (12 in total) taking exams in this manner in the 1st Semester of 2011 academic year.


Publication of Student Research Findings

The Undergraduate School of OUJ has set up graduate research courses where students produce research reports while receiving direct guidance from advisory teaching staff. Many students take the courses each year. From 2007 academic year, a list of graduate research themes and graduate research reports that present research findings are published on the Campus Network Website as an information service to students interested in taking graduate research courses. In 2011 academic year, a list of graduate research report themes and the full text of 26 graduate research reports of the preceding 2010 academic year were published.

For the Graduate School, the Open Forum (The OUJ School of Graduate Studies Education Research Result Report), primarily compiled from School of Graduate Studies Master's Course graduation theses, has been published since March 2005. The Open Forum is aimed at providing information to

current and future enrolling students, disseminating information from the university to society, and being used as materials

that specifically show the details of educational research at the Master's Course as well as the self-inspection and self-evaluation of teaching staff. The seventh issue, published in March 2011, contains 12 theses with 35 research notes selected from among all the 396 Master's Course graduates from the 2009 academic year.

Open Courseware

Open Courseware (OCW) refers to "activities to publish lectures and related information officially offered by universities free of charge over the Internet."

OUJ, which was established with the aim of providing "open university education" where all people wishing to learn can do so anytime and anywhere, supports the OCW concept. OUJ joined the Open Courseware Consortium as a full member in 2009 and has made a wide variety of courses publicly available online since 2010.

The OUJ Archives

Since it began broadcasting lectures in April 1985, OUJ has produced and broadcast more than 2,000 subjects on radio and television.

Broadcast tapes holding subjects that were discontinued when their role ended are stored in a "Permanent Archive" located in the OUJ Administration Building.

To commemorate the start of BS digital broadcasts in October 2011, OUJ began creating and broadcasting a series of informational programs under the title "Watch Notable Lectures Once More — The OUJ Archives." The aim of the initiative was to pick the especially popular TV subjects from among the valuable lectures being run at the time and have a wider audience view them again. After adding new openings for the programs with course outlines and lecturer introductions, the classes are shown almost entirely as they originally aired. The subjects to be picked up are those recommended by a committee made up of teaching staff from each course, and 25 such videos were produced in 2011 academic year.

"Expert" Subject Group Credit Certification System Expansion

"Expert", an original OUJ subject group credit certification system, was introduced in the 2006 academic year. Objectives of and interest in subject matter in a given field are acquired through the completion of specific university designated instruction, and this confirms the achievement of a systematic study to that end. With the 2007 revision of the School Education Act, "certified evaluation and accreditation system" regulations for universities also came into effect, and as a result "Expert" was implemented again from the 2008 academic year to respond to the "certified evaluation and accreditation system."

While the system was initially started with ten plans, new plans have been created every year since, and with the addition of the Fundamental Clinical Psychology Plan in the 2nd Semester of 2011 academic year there are now 24 plans on offer. The number of individuals that received subject group credit certification was 223 in 2006 academic year, 1,092 in 2007 academic year, 2,848 in 2008 academic year, 2,552 in 2009 academic year and 2,469 in 2010 academic year, with a similar number of certifications expected for 2011 academic year. As of December 31, 2011, a total of 10,350 certifications have now been obtained, indicating that the system has established itself as a study goal among students.

Helping People Advance Their Careers Acquiring Qualifications

Some credits acquired at OUJ can be utilized to earn the following types of certification.

Qualification for the National examination for registered nurses; teacher certification for a higher class, additional subject, or a sequentially higher or lower school level; school librarian certification: second level special education teacher certification (mentally disabled education); teacher for the disabled certification; nutrition teacher certification; library curator certification; social education superintendent certification; social welfare director certification; short course for care worker subjects.

OUJ has been conducting teacher's certificate renewal training since the 2009 academic year in connection with the start of the teacher's certificate renewal system. Making the best use of the characteristics of OUJ, television, radio or Internet lectures are used to enable teachers to undergo training from anywhere in Japan. Lectures are offered twice a year (summer semester or winter semester) and in training during the 2011 academic year approximately 5,000 participants took around 17,000 subjects.

Educational Support for Other Institutions

Credit-Transferring Initiatives

OUJ has been assertive in concluding credit-transferring agreements with educational institutions nationwide.

In 2011 academic year, OUJ signed credit-transferring agreements with 15 more universities and junior colleges and two technical colleges, bringing the total to 371.

Participation in the 25th AAOU Annual Conference

Over a three day period from September 28 to 30, 2011, the 25th Annual Conference of the Asian Association of Open Universities (AAOU) was held in Penang, Malaysia. Wawasan Open University served as the host university, and the conference took place on the main campus of the university. With some 350 participants from 68 institutions around the world, it was an extremely lively event. From OUJ, eight teaching staff, including President Yoichi OK-ABE, took part in the conference.

The theme of the 25th AAOU Annual Conference was "Transforming Asia through Open Distance Learning," and participants discussed how to comprehensively raise the educational level in Asia through distance learning and open education.

In addition to President OKABE taking part in the AAOU

Board Meeting, the teaching staff moderated respective panel discussions, delivered reports and engaged in other activities during the conference.

As the 26th AAOU Annual Conference is scheduled to be held over three days from October 16 to 18, 2012 at the Makuhari Messe International



Conference Hall and hosted by OUJ, the fact that the next conference will be held in Japan was promoted during the closing ceremony of the conference.

Participation in the 2011 ICDE Standing Conference of Presidents (SCOP) and 24th ICDE World Conference

OUJ is an institutional member of the International Council for Open and Distance Education (ICDE), and played an active part in each of the ICDE conferences in 2011.

From June 20 to 22, 2011, the ICDE-SCOP 2011, whose aim is to sharing information on distance education taking place around the world, was held in New York. Two representatives from OUJ, one of whom was President OKABE, attended the conference.

Running from October 2 to 5, 2011, the 24th ICDE World Conference was hosted by Universitas Terbuka on the island of Bali in Indonesia. Held in alternating years, the 2011 conference included discussions on a new approaches to









open and distance learning (ODL) under the theme "Expanding Horizons – New Approaches to Open and Distance Learning." More than 600 attendees from 50 countries took part. From OUJ, seven teaching staff, including President OKABE took part, four of whom gave presentations in parallel sessions and the like. With OUJ acting as a sponsor of the 2011 conference, the name and logo of OUJ was displayed alongside other institutions on the distributed programs and images displayed inside the venue, making it a great opportunity to make OUJ's presence felt to the world.

The 3rd KNOU, OUC, OUJ International Seminar

On Monday, September 19, 2011, the third KNOU, OUC, OUJ International Seminar was held at the China People's Palace in Beijing, China. Following venues in South Korea (Seoul) in 2009 and Japan (Chiba) the following year, the 2011 seminar was held in China. "Reforming Educational Management in Open Universities" served as the theme of the 3rd seminar. Four members from OUJ including President OKABE, Professor YUAN and Associate Professor OHASHI, joined by 23 members from the Open University of China (OUC and open universities in China) and six members from Korea National Open University (KNOU). President OKABE expressed his gratitude for the email messages of sympathy received from each country after the March earthquake and introduced the next AAOU Annual Conference, which will be held in Makuhari in 2012. In the first session, "Effective Management of Open Universities," Associate Professor OHASHI described the current situation at the Student Support Center of OUJ. In the next session, "Facilitating Lifelong Learning and Learning for All Through Integration of ODL Resources," Professor YUAN presented information about the utilization of ICT at higher education institutions in Japan. Both sessions developed into lively discussions.

Tours were conducted in conjunction with the seminar, at OUC and Beijing Radio and Television University on Tuesday, September 20, and at Study Center of OUC on Wednesday, September 21.





2011 International Symposium

The OUJ Center of ICT and Distance Education (CODE) invited key figures from the UK, Canada, Australia, Hong Kong and within Japan to the 2011 International Symposium held at the Makuhari Messe International Conference





Hall on February 23, 2011. After a welcoming address from then-OUJ President ISHI, the event proceeded under the theme of "Digital Literacy in Higher Education and Lifelong Learning," with Professor Kumiko AOKI acting as chairperson. On the point of enabling educational models based on learning-centric and constructivist approaches in higher education and lifelong learning, five invitational lectures and panel discussions took place regarding digital literacy and its potential as the driving force that will set off a paradigm shift in education. During each lecture, the challenges faced in developing the digital literacy of students and teaching staff as well as future directions were discussed.

Contributions to Society

Since its founding, the Open University of Japan has earnestly provided philanthropic services as an open university. The following are examples of the diverse philanthropic efforts made by our faculty members.

Science Council of Japan

The Science Council of Japan was established in January 1949 with the aim of reflecting and instilling science in government administration, industry and the lives of citizens. Operating under the jurisdiction of the Prime Minister, the council was established as a "Special Organization" that undertakes its duties independent from the government. The council fulfills the following two functions.

- ■To deliberate on important issues concerning science and help solve such issues.
- ■To coordinate among scientific studies to achieve higher efficiency.

The Science Council of Japan (SCJ) is the domestic and overseas representative of some 840,000 scientists in all areas of the humanities, social sciences, biological sciences, physical sciences and engineering in Japan, and discharges its duties through a council body comprising 210 council members and some 2,000 regular members.

The primary roles of the SCJ are 1. Presenting policy recommendations to the government; 2. International activities; 3. Establishment of networks among scientists; and 4. Raising public awareness about the roles of science.

Obtaining University Accreditation

During the 2010 academic year, OUJ underwent examination by the National Institution for Academic Degrees and University Evaluation, and on March 25, 2011 was evaluated as having satisfied the university evaluation criteria.

The key merits of OUJ included "The Study Centers and Satellite Spaces set up at 57 locations nationwide not only offer classroom sessions and credit certification exams but conduct study guidance and consultation, allow the review, reading or loaning out of broadcast materials and books, and function effectively to support the studies of the students of an open university," and "To create broadcast and printed materials, conduct classroom sessions and other services, OUJ allocates not only specialized teaching staff but adequate numbers of visiting lecturers and part-time instructors, and by engaging in education in close contact with full-time lecturers, endeavors to offer high-quality education across a wide range of fields."

The examination also noted the expectation that the utilization of ICT would be further improved, and OUJ is currently deliberating on improvements through voluntary inspections and evaluation committees.

Lecture Assessments

The Open University of Japan aims to improve its curriculum, teaching methodology, and learning support systems. As part of self check and appraisal activities in this regard, lectures are assessed in the following three ways.

Lecture Assessment by Students

Applicable Subjects: All subjects being offered for the first time during the academic year in question

Appraisers: Extracted from among students taking the subject during the first semester of the academic year in question

Lecture Assessment by Study Center Directors and Visiting Lecturers

Applicable Subjects: A selection of subjects being newly offered during the academic year in question

Appraisers: Study Center directors or visiting lecturers specializing in the same or a similar field as the selected subject

Lecture Assessment by Full-time Lecturers

Applicable Subjects: A selection of subjects being newly offered during the academic year in question

Appraisers: Full-time lecturers of the course or program of the selected subject

Assessment results are fed back to the chief lecturer of each subject, full-time lecturers and persons responsible for subject development at the Department of Broadcasting and Department of Production. Revisions to lectures are made on an as-needed basis.

The results are also used to improve questions used in tutorials through correspondence and credit certification examinations, and to provide better learning support services including responses to student inquiries.

Creating Subjects Through a Painstaking Three-Year Process

To produce better course materials, OUJ is making improvements to its course material production schedule. The improvements currently being worked on involve allowing the time to concentrate on the production of each type of course material. Previously, broadcast materials and text-books were produced in tandem in the year prior to a subject being offered, while under the improved system, the creation of textbooks would begin separately a year earlier.

In 2011, when materials development was implemented in accordance with this schedule, a meeting of chief lecturers was held regarding courses to be offered during the 2014 academic year. Chief lecturers are the full-time lecturers in charge of OUJ broadcast lecture subjects who write text-books, produce broadcast materials, prepare questions and mark answers for tutorials by correspondence and credit certification exams, and respond to query cards.

OUJ lectures consist of broadcast lectures and classroom sessions. Both may be given by lecturers who are researchers at other universities and various institutions, visiting lecturers or part-time lecturers, as well as by full-time OUJ lecturers. Written and verbal information

about the special attributes of OUJ and its students is provided to visiting professors and part-time lecturers in advance. However, there are many tasks that chief lecturers involved in broadcast teaching undertake that they would not experience at a campus-based college, such as airing lectures, writing textbooks, providing tutorials through correspondence and preparing credit certification examination questions. For this reason, before broadcast program production, OUJ assembles all chief lecturers under one roof, regardless of whether they are full-time or visiting lecturers,

to explain all aspects of broadcast lecturing. This is also an opportunity for the lecturers to exchange views with the directors and editors in charge of course materials on ways to produce materials which are easier to understand.

Chief Lecturer Meeting

Faculty Development (FD) Initiatives

As a part of Faculty Development (FD) efforts, presentations were held on October 27, 2011 and March 21, 2012.

Professor Makiko MIWA presented a report on University of Maryland University College, including the new lecturer training program, ongoing FD program, the promotion of talented lecturers, services and sources of information on appraisals and the lecturer evaluation system.

Associate Professor Rie OHASHI gave an explanation of the differences between classes at The Open University (England) and OUJ, and proposed materials for studying the possibility of applying the instructional methods employed at The Open University.

Associate Professor Akemi KAWAFUCHI delivered an interim report on the contents of interviews with highly-experienced lecturers on techniques and tips for producing television-based broadcast subjects.

Following the presentations, lively discussions with par-

ticipants ensued.

OUJ has also held FD seminars and luncheon seminars.

One example is "PCs from the ground up," a classroom sessions taught at Study Centers across Japan which aims to instruct OUJ students on the operation of PCs. Since the 2010 academic year, lecturers running the classroom sessions have reported on things such as course content, impressions and points for improvement to help improve the subject. In a bid to improve the quality of broadcast lecturer programs, workshops are also held with the staff in charge of program production serving as instructors and engaging in lively discussions on topics such as the future role of broadcast lectures. OUJ will continue to pursue FD activities and strive to improve the quality of its instruction.

Now Offering "UPO-NET for OUJ"

UPO-NET provides instructional e-learning materials to universities and other institutions over the Internet. 35 instructional e-learning materials covering fundamental, first-year, pre-university and career education have been produced and distributed by OUJ, and are being utilized by many students.

"UPO-NET for OUJ" provides these instructional materials to OUJ as part of its learning support and student services. OUJ students can utilize these materials for self-directed study and learning separately from university lectures to study areas in which they are weaker through repetition and review. Some 15,000 students registered and used the materials during the 2011 academic year.



CODE has also developed and currently distributes on a trial basis remedial instructional materials for broadcast lectures designed for use at institutions with whom OUJ has credittransferring or dual-enrollment agreements, as well as instructional e-learning materials to help those taking the National Nursing Examination. Some of the instructional materials can

be studied using devices such as mobile phones, iPads and iPhones.

This is important research in considering the role and direction of future higher education in Japan.

Research on a Mixed Reality-Based Exhibit Explanation System

Museums are excellent learning environments that allow contact with real items. However, simply visiting a museum does not lend itself well to learning. For instance, people who are not familiar with paleontology may find it difficult to learn about the differences between dinosaurs no matter how long they look at their skeletons. This research uses technology that fuses real spaces with 3D computer graphics to develop a new system for explaining exhibits. Unlike

explanations through pictorial books or video footage, visitors can learn in a sensory fashion because the explanations are presented atop the actual skeletons. Photos serve as the content for explaining the skeletal structure of the dinosaurs. This experience aims to serve as the trigger enabling study through the examination of specimens. Experiments of the system were conducted at the Smithsonian Institution National Museum of Natural History in March 2011.

With the cooperation of the "Nanohana no Kai" (Representative: Kazuko SUGI-YAMA), a voluntary group for which has been supporting visually-impaired OUJ students for the past 12 years, a

website that can be easily read by text-to-speech software was developed. Working in coordination with the Student Section of the Department of Academic Affairs, a "For Visually-impaired Users" link was placed on the top page of the OUJ website. The special website allows visually-impaired users to access important information essential to university life, such as examination and lecture schedules, lists of subject textbooks translated into Braille and application procedures on an as-needed basis.


Prestigious Open University of Japan Student Ceremony

New Trends at The Open University of Japan

The Open University of Japan Library Collections

The OUJ Library published "The Open University of Japan Library Collections" book in March 2011.

The book includes more than 80 distinctive pieces from among the rare books stored at the library. Themed after Western perspective of Japan, the collection includes literary works such as expedition and travel writings on trips to Asia and Japan, and many Japan-oriented materials sent

out from Japan to the West from the end of the Edo period to the Meiji period, such as old photographs and illustrated crepe paper books. The collection also houses materials such as Newton's Principia and Seibold's Nippon.

The materials not only contribute to research but are also utilized in OUJ broadcast materials and textbooks. Since 1996, OUJ holds exhibitions of the collection presenting

rare items such as old photographs and illustrated crepe paper books to the public at various locations around Japan.

With the book listing its collections, OUJ seeks further use of the precious materials it holds in and out of OUJ.

The Third OUJ Student Essay Contest

Launching a BS Digital Broadcasting Station

In October 2011, the Open University of Japan Foundation commenced BS Digital broadcasting on television channels 231 to 233 and on BS radio channel 531.

As with the terrestrial digital broadcasts conducted in some parts of the Kanto region, BS Digital broadcasting has enabled an improved learning environment nationwide, with the provision of high-definition video, program delivery through a multi-broadcast system where three channels are broadcast simultaneously, and the provision of Study Center information, etc. through data broadcasting.

BS Digital broadcasts can generally be viewed by connecting a parabolic BS reception antenna, as many televisions capable of receiving terrestrial digital broadcasts are also equipped with BS tuners.

Also note that CS broadcasts (Sky Perfect! SD) will cease at the end of March 2012.

In commemoration of the start of BS Digital broadcasts on the October 1st station launch day, special programs were aired to provide information about The Open University of Japan, not only to the students watching but to general viewers around Japan as well.

The lineup of special programs included "Watch Notable

Lectures Once More: The OUJ Archives," "Fellow Learners" and "Let's Talk about The Open University of Japan!"

"Watch Notable Lectures Once More: The OUJ Archives" showcased the best scenes from notable past lectures from likes of Shoichi OZAWA and Susumu NISHIBE.

"Fellow Learners" featured students from around Japan studying in a variety of environments, including students preserving their passion for study despite being affected by earthquakes or tsunamis.

"Let's Talk about The Open University of Japan!" broadcast the scenes from a Symposium that gathered OUJ students in their 20s to 80s, OUJ President OK-ABE and Chairperson SHIRAI, as well as Yokohama Mayor Fumiko HAYASHI, who had been able to study at OUJ. The program showed a passionate exchange of views about "the wonder of continuing to learn throughout one's life" and "the future of OUJ."

Completion of the New Tokyo Bunkyo Study Center Building

The new Tokyo Bunkyo Study Center building opened in September 2011.

The new building is situated in a location with excellent access to transportation, just a three-minute walk from Myogadani Station on the Tokyo Metro Marunouchi Subway Line. The building is a joint construction by OUJ and Tsukuba University with seven floors in total (six aboveground and one basement level) with an inner garden placed at the center to produce a relaxed and comfortable space with ample daylight. OUJ will mainly use the basement level as well as the second and third floors. In addition to a large lecture hall which can be used for various lectures as well as enrollment ceremonies, there is a large library room, seminar rooms, and an audio-visual learning room where students can re-watch and study broadcast materials. The student lounge is an open space for communica-

tion with fellow students and breaks between classes.

The number of classroom sessions has been doubled, and students can take an even greater variety of sessions. From the second semester the number of classroom session sub-

jects will be increased from 80 to 180 (around 300 subjects per year), giving students the ability to take classes across a

wide range of fields. Experiment-oriented classes that can't be experienced through broadcast lectures such as physics, chemistry and biology have been added, giving people the opportunity to share the joy of learning with fellow students.

Creating of the First "Urban Campus" (Tokyo Shibuya Study Center)

In April 2012, OUJ plans to establish a new facility in Shibuya, a diverse hub of culture, fashion and IT, as OUJ's first "Urban Campus."

Based on the concept of a "close by and convenient campus" just five minutes' walk from Shibuya Station, the Tokyo Shibuya Study Cen-

ter will be a new source of information for students studying for a range of purposes, from earning a degree to career advancement or self-fulfillment.

The Study Center also promises to be a place visited and used by large numbers of people from all over Japan as a landmark that actively disseminates information about OUJ to prospective students.

Basic functions will mirror those of existing Study Centers, such as re-watching of broadcast lectures, classroom sessions and course counseling. The center is also expected to function as a new hub of lifelong learning by attempting a number of other approaches such as early-morning and late-night classroom sessions and new projects aimed at business people.


